District Wide Recycling

As we enter this school year, there's a renewed vigilance on implementing a consistent recycling program in our schools. The only way that we can be successful is if we partner as a district to commit to the recycling program that's currently in place. This team-oriented approach involves administration, faculty, staff, custodial, maintenance, students and parents. The result will be a school district that is healthier, cleaner and greener. There is also a cost saving component to recycling over regular garbage disposal. The method of recycling employed by our district is called "single-stream" recycling.

Single-Stream (also known as 'fully commingled" or "single-sort") recycling refers to a system in which all paper fibers, plastics, metals and other containers are mixed in a collection truck, instead of being sorted by the depositor (district) into separate commodities and handled separately throughout the collection process. In single-stream, both the collection and processing systems are designed to handle fully commingled mixture of recyclables, with materials being separated for reuse at a materials recovery facility.

In simple terms, everything that can be recycled should be put into a designated recycling trash can or bin. However, only certain grades of plastics will be collected for recycling. This is because only Polyethylene Terephalate (PET #1) and High Density Polyethylene (HDPE #2) have established recycling markets. Simply look on the bottom of the container and you should see the recycling symbol (3 chasing arrows) with a number in the center. If the number is a #1 or a #2, the container can be accepted for recycling. In order to save space in your recycling bin, remove the caps and crush the plastic container.
