

Chromebook Damage Protection Plan Options –



Clearview Regional School District

Two Year Option

In accordance with Policy 5513: Care of School Property, students are responsible for the proper care of school property and the school supplies and equipment entrusted to his/her use. Students and parents will be responsible for district-owned technology property that is issued to them, just as they are for other district-owned items such as text books, calculators, athletic equipment, or library books. The Clearview Regional School District recognizes that there is a need to protect the investment by both the district and the student/parent. If the device is damaged, the district will repair or replace it, but students/parents will be responsible for the cost of those repairs or replaced devices.

However, the liability on families/students can be reduced significantly by taking part in the district's Chromebook Protection Plan program. For \$60 (non-refundable) for the **2018/2019** school year and the **2019/2020**, per device, the Chromebook Protection Plan program will repair or replace the device for two damage occurrences. If the Chromebook is repaired, the family will be offered to renew the Protection Plan for an additional \$30 per instance after the second occurrence. This Protection Plan program covers accidental damage. It does NOT cover loss, theft, damage by flood/fire/intentional destruction. The district strongly recommends purchasing our Chromebook protection plan.

Choosing to enroll in the district's Chromebook Protection Plan is optional. You may elect to pay for damages out of pocket or cover the device by your own personal insurance. Parents/guardians who select no plan will be financially responsible for loss, theft, or all damages not covered by the manufacturer's warranty. Typical repair and replacement costs are listed below.

Replace entire Chromebook \$300
Replace screen \$90
Replace keyboard/touchpad \$50
Replace cracked/damaged shell/casing \$100

Replace power cable/charger \$30
Replace transport case \$20
Liquid spill \$200

Parents that wish to carry their own personal insurance to protect the Chromebook should consult with their insurance agent for details about your personal coverage of the Chromebook and accessories. Parents will need to show proof of insurance at the time of laptop pick-up before the student(s) is/are allowed to check out the device.

	<p>School District Protection Plan Program</p>	<p>I choose to pay the school district for the Protection Plan for accidental damage coverage in the amount of \$60 per Chromebook for 2 consecutive years. I understand that the Chromebook Protection Plan Program will repair or replace the device two times. After the plan has been utilized twice, I will be offered to renew the Protection Plan for an additional \$30 per damage occurrence. I also understand that this Protection Plan program covers <u>accidental</u> damage. It does NOT cover loss, theft, damage by flood/fire/intentional destruction. See below for hardship instructions.</p>
	<p>Personal Insurance</p>	<p>I will cover the Chromebook, charger, and transport case under my own insurance policy. I agree to pay the district the amount received from my insurance company plus any additional amount needed to cover the Chromebook replacement, charger, and transport case not to exceed \$300. Note: Most insurance policies only provide in-home coverage. My policy must provide a rider for coverage wherever my child takes the laptop.</p>
	<p>Personal Liability</p>	<p>I agree to pay for the replacement or repair of the Chromebook, charger, and transport case not to exceed \$300 should any of the aforementioned items be stolen, lost or damaged.</p>

Additional Information: In cases of theft, vandalism, and other criminal acts, a police report, or in the case of flood/fire, a flood/fire report must be filed by the parent or guardian. A copy of the police/flood/fire report must be provided to the school district in a timely manner.

Intentional or Repetitive Damage or Abuse: Parents/guardians are responsible for full payment of intentional damages/abuse to Chromebooks. The School District Protection Plan program does not cover intentional damage/abuse of the device.

Hardship Instructions: If your family qualifies for the Free/Reduced Meal Program through the Federal Government, you may request a one-time waiver of the insurance fee. If the device is damaged, you will be responsible for the insurance fee of \$20 thereafter.
